## **ABSTRACT**

This study aims to analyze the factors that affect the thin capitalization of multinational companies in Bursa Efek Indonesia. Thin capitalization is the practice of double taxation by way of finance branches or subsidiaries with greater interest debt rather than with equity. Independent variables used in this study is multinationality, utilization of tax haven, withholding taxes and tax uncertainty while the dependent variable is the thin capitalization.

The population of this research is that companies listed in Indonesia Stock Exchange in 2012-2014. Sampling was done by purposive sampling technique. Based on purposive sampling, obtained a sample of 75 companies one year. The method of analysis used to test the effect of independent variables on the dependent variable is the Ordinary Least Square (OLS). The results of this study indicate that (1) Multinationality significant effect on thin capitalization, (2) Utilization of Tax Haven significant effect on thin capitalization, (3) Withholding Taxes significant effect on thin capitalization, and (4) Tax uncertainty significant effect on thin capitalization.
